# Administrative history / Biographical sketch

#### Note

Kiss & Tell is an artistic collective based in Vancouver, British Columbia. Members include Persimmon Blackbridge, Lizard Jones and Susan Stewart. The group formed out of a larger meeting of feminists in 1984 who had gathered to discuss pornography, erotica, and sexual representation in art. The collective's work frequently addresses issues of censorship and lesbian sexual politics.

The group's major production was the interactive photographic exhibition "Drawing the Line," which launched in 1989 and toured for several years afterwards. The exhibition consisted of a series of 98 photographs taken by Susan Stewart with Lizard Jones and Persimmon Blackbridge as models, depicting a range of lesbian sexual practices. A postcard book "Drawing the Line: Lesbian Sexual Politics on the Wall," featuring 40 images and comments from the exhibition, was published by Press Gang Publishers in 1991. The group's second book, "Her Tongue on my Theory: Images, Essays and Fantasies" (1994) was the recipient of a Lambda Literary Award in 1995. The group has also produced performance pieces, including "True Inversions" (1992), images from which are contained in the book "Her Tongue on my Theory," and "That Long Distance Feeling: Perverts, Politics & Prozac" (1997).

Lorna Boschman has made three short films about Kiss and Tell: "Drawing the Line" (1992), "True Inversions" (1992), and "Before the New Millennium" (2007). In the summer of 2015, the Vancouver Queer Arts Festival featured the exhibition "Drawing the Line in 2015," celebrating the 25th anniversary of the show.

# **Custodial history**

The records were in the custody of Susan Stewart until their acquisition by Simon Fraser University Library, Special Collections and Rare Books.

# Scope and content

Fonds consists of records created and accumulated by the Kiss and Tell collective over the course of the collective's operations. Records include photographs, correspondence, exhibition specifications and guidelines, and promotional and press materials.

# Series MsC-165-0-1: Drawing the line records

Scope and content:

Series consists of records created and accumulated by the Kiss and Tell collective during the production, exhibition, and promotion of the photographic exhibition "Drawing the Line" and the book "Drawing the Line: Lesbian Sexual Politics on the Wall." Records include photographs, correspondence, exhibition specifications and guidelines, promotional and press materials, and articles. Photographs include not only those 98 images ultimately selected for use the "Drawing the Line" exhibition, but also many more photographs taken by Stewart in the process of creating the artwork, as well as photographs of the exhibition itself.
