Section 1: Fonds and Series Level Descriptions

Fonds Level Description

Title: Daryl Duke fonds

Dates of creation: 1940-2006

Extent: 8.90 m of textual records and other material

Biographical sketch:

Film director Daryl Duke's Emmy Award winning career spans a wide range of accomplishments in feature films, television dramas, documentaries and television specials. In a career that spanned more than half a century, Duke worked as a producer and a director, for both Canadian Television networks, for all three major U.S. networks and for most of the major studios in Hollywood.

Film and television assignments took Duke to South America, China, the countries of Southeast Asia and India, as well as the Middle East, Yugoslavia, Europe and England. His work was seen at many festivals including the famous Cannes International Festival of Film where his American movie, *Payday*, was an entry in the official festival category, "The Director's Fortnight."

Duke directed the 10-hour mini-series from the bestselling book *The Thorn Birds*. This series ranks among the most watched television dramas in the United States and Canada and continues to be broadcast around the world. For his work on this series, Duke received Emmy and Director's Guild of America nominations.

Duke was honoured with an Emmy for his direction of "The Day the Lion Died," an episode of *The Senator* television series for NBC. His production of *I Heard The Owl Call My Name*, a 90-minute drama for CBS and filmed on the west coast of Vancouver Island, earned Duke a Christopher Award.

Duke also received a National Society of Film Critics Special Award for his feature film *Payday* and the Canadian Film Awards (now call the Genies) Best Director and Best Picture Awards for the film *The Silent Partner*.

A native of Canada and a graduate of the University of British Columbia, Duke began his career as a film editor, writer and director for the National Film Board of Canada, internationally recognized for its excellence in film.

Duke originated the first television show from the Canadian Broadcasting Corporation's (CBC) station in Vancouver, CBUT, which went on the air in the early 1950s. While at the Vancouver studios of the CBC, Duke produced and directed variety programs, a classical music series, dramas and public affairs documentaries for both west coast audiences and the CBC network.

As Executive Producer and Director of the CBC series *Quest*, Duke's productions included documentaries, music and comedy shows and documentary programming. The Toronto Star newspaper named Duke "Entertainment Star of the Year" for his work on the series.

In the United States, Duke produced *The Steve Allen Show* for the Westinghouse Broadcasting Company in Hollywood, and later the *Les Crane Show* in New York for the ABC television network. He also served as executive producer for the prime time CBS series *Sunday*.

In the mid-1970s, Daryl Duke founded and launched the independent television station CKVU-TV in Vancouver, Canada. He was its first President, Chief Executive Officer and Chairman of the Board.

Duke has written many articles and essays on culture and media for *The Globe and Mail*, *The Canadian Forum*, *The Georgia Strait*, *The London Free Press* and *The Vancouver Sun*.

In 1997, Duke was inducted into "Starwalk" and the B.C. Entertainment Hall of Fame. In 1999, Duke was the first recipient of the "Outstanding Achievement Award for an Individual" at the Leo Awards. Duke was also member of the Board of Directors of BC Film, as well as a member of the Steering Committee of The Friends of Canadian Broadcasting.

In the fall of 2000, Duke was inducted into the Canadian Association of Broadcasters' Broadcasters Hall of Fame, and in October 2003, Daryl Duke was honoured by the Director's Guild of Canada with a Lifetime Achievement Award recognizing more than a half-century of creative work in Canadian and international productions. In June 2004, Duke received the Doctor of Fine Arts *honoris causa* from Simon Fraser University in Burnaby, British Columbia.

Daryl Duke died in West Vancouver, British Columbia on October 21, 2006 due to pulmonary fibrosis.

Scope and content:

The fonds consists of records created by Duke from approximately 1946 to 2006. They are related to all aspects of Duke's life and career. Among other types of records, the fonds includes:

Physical description: Includes ca. 430 photographs, 54 videocassettes, 22 audio reels, 15 books, 12 architectural drawings, 4 maps, 4 placards, 2 posters, and 1 mini-cassette.

Associated material: Norman Klenman was a close friend and working partner of Daryl Duke for most of his career. His presence is felt throughout the collection and his own fonds can be found in the SFU Special Collections and Rare Books Archives, in MsC 101.

Arrangement: The first accession of the Duke fonds arrived in forty-five banker boxes. While much of the material had an established arrangement, an initial inventory describing the items in each box arrived with the accession. Each original box contained items related to many aspects of Duke's activities but there was little apparent order within each box. The archival assistant therefore assigned series while processing the fonds. Series are based on the major activities and types of materials present.

As records were transferred into archival boxes and folders, the archival assistant physically rearranged the individual files to make them more coherent and accessible for future researchers. The original order within the files has not been changed.

The second accrual to the Duke fonds consisted of fourteen banker boxes. The same series were assigned to the new material, and again, the archivist physically arranged the individual files for coherence and accessibility.

Accruals: Further accruals are expected.

Series Level Descriptions

Series 1: CKVU

Dates of creation: 1974-1997

Extent: 1.25 m of textual records. - 9 photographs.

Scope and content: Series consists mainly of textual material pertaining to the business transactions, staffing, and programming of CKVU-TV Vancouver. Due to the takeover of the station by Global TV and the subsequent litigations, this series also contains various legal records including transcripts of court proceedings, settlement contracts, affidavits and subpoenas. This series also includes business correspondence and personal information regarding Duke's role within the organization.

Series 2: CBC

Dates of creation: [196-]-2005

Extent: 0.40 m of textual records and other material

Scope and content: Series consists of records related to film and television productions that Duke was involved in when employed by the Canadian Broadcasting Corporation (CBC). Records include drafts of screenplays, scripts, publicity, administrative documents, and other records related to the creation and production of Duke's projects. This series contains records related to the following projects:

Dates of creation: 1994-2004

Extent: 0.10 m of textual records

Scope and content: Series consists mainly of textual material pertaining to Duke's involvement with the Friends of Canadian Broadcasting. This series includes business correspondence and personal information regarding Duke's role within the organization.

Series 4: Banff Television Festival

Dates of creation: 1997-2004

Extent: 0.10 m of textual records

Scope and content: Series consists mainly of textual material pertaining to Duke's involvement with the Banff Television Festival. This series includes business correspondence, personal notes and information regarding Duke's contributions to adjudications and presentations within the organization.

Series 5: Vancouver Awards Show

Dates of creation: 1987-1990

Extent: 0.25 m of textual records

Scope and content: Series consists mainly of textual material pertaining to Duke's involvement in organizing and scripting the Vancouver Awards Show. This series includes business correspondence, personal notes, draft scripts, publicity and information regarding Duke's contributions to the show's production.

Series 6: General business correspondence

Dates of creation: 1965-1993

Extent: 0.25 m of textual records

Scope and content: Series consists of records related to Duke's personal and administrative affairs. This diverse series includes:

- · Personal notes and memos written by Duke for family, friends and staff
- Correspondence received by Duke from family, friends and business associates
- Administrative correspondence received by Duke from agents, publishers and other associates
- · Receipts, bills and other financial records

Series 7: Personal correspondence

Dates of creation: 1948-2006

Extent: 0.95 m of textual records

Scope and content: Series consists of records related to Duke's personal and administrative affairs. This series includes:

- Correspondence received by Duke from family, friends and business associates
- Administrative correspondence received by Duke from agents, publishers and other associates
- Miscellaneous ephemera collected by Duke

Series 8: Essays and articles

Dates of creation: 1940-2005

Extent: 0.55 m of textual records

Scope and content: Series consists of drafts, final versions, correspondence, notes and clippings related to Duke's work as an essayist.

Series 9: Personal notes

Dates of creation: [196-]-2005

Extent: 0.20 m of textual records

Scope and content: Series consists of notes, notebooks/journals, and press clippings that are both specifically related to projects and also those not directly linked to a specific project. Topics include:

Series 10: Personal journals

Dates of creation: 1945-2005

Extent: 2.05 m of textual records

Scope and content: Series consists of notebooks, journals, notes and press clippings. From about 1945 to 2005 Duke made nearly daily entries in notebooks. These notebooks contain Duke's thoughts, observations and concepts for future projects ranging from articles to screenplays, legal proceedings, housing plans and travel accounts.

Series 11: Agendas

Dates of creation: 1977-1984

Extent: 0.35 m of textual records

Scope and content: Series consists of 8 *Economist* hard-bound agendas. These agendas outline Duke's personal and professional schedules during this time period.

Series 12: Personal publicity

Dates of creation: 1960-2004

Extent: 0.20 m of textual records

Scope and content: Series consists of magazines, newspapers, clippings and photocopies of articles about Duke or his various projects. Clippings were either set aside by Duke himself, or received from professional press clippings companies.

Series 13: Film and television works

Dates of creation: 1950-2000

Extent: 1.85 m of textual records and other material

Scope and content: Series consists of records related to film and television productions that Duke was involved with. Records include drafts of screenplays, scripts, publicity, call sheets, administrative documents, shooting scripts, itineraries and other records related to the development and production of Duke's cinematic projects.
